Authors' Style Sheet

1. <u>Title page</u>

- a. The title should be Times New Roman, 16 pt, boldfaced. Capitalize the first letter of the first content word only.
- b. Remove any author information.
- ★ Review policy: As the journal has adopted a double blind reviewing policy, it is up to the authors to make sure that the submitted documents do not reveal their identity in the main text, citations, references, footnotes, acknowledgements, document properties, or any running header. Submissions that do not remove such features will be returned to the author for correction before review.
- **★** Once accepted, the author(s) should format their title page following the style in recently published articles in Concentric and can add back information previously removed due to the double blind policy.
- ★ Once accepted, the Chinese title and the running head should be provided as well (the running head should be within 50 characters including the spaces and be placed on the upper right corner of each page).

2. Abstract

- a. The font is 10 pt Times New Roman.
- b. Within 200 words
- c. Keywords: 4-6 words (Separate these keywords with commas.)

3. Section headings

- a. Capitalize only the first letter of the first word and boldface all the words.
- b. A section should include no more than three layers. All headings begin flush left and should follow the following numbering system:
 - 1. Main heading
 - 1.1 Second layer
 - 1.1.1 Third layer

4. Fonts, typefaces, and punctuation of main text

- a. Indent the first line of every new paragraph with 4 spaces.
- b. Italicize in-text examples and non-English words, and put translations of non-English words in Times New Roman in single quotation marks.
 e.g.: As in English academic texts, Chinese spoken discourse contains a number of personal pronouns to signal a speaker's attitude, e.g., women(de) 'we(our)', wo xiang 'I think', dui wo lai shuo 'as for me'.
- c. Italicize and use lowercase letters like t and p in the t and p values.
- d. Insert spaces before and after mathematical symbols such as =, >, <, etc.

5. Footnotes


- a. Footnotes should be numbered consecutively throughout the article.
- b. No space is needed between examples and adjacent texts.
- c. Examples should be presented in Roman numerals.

6. Linguistic examples and rules in main text

- a. Number examples throughout the manuscript.
- b. Insert one space line between examples/rules and adjacent texts.
- c. No space is needed between consecutive examples or rules.
- d. Examples should not be indented and should be presented as shown below, and please do not use the auto numbering system.
 Sample:
 - (1) a. Down the hill rolled the baby carriage.
 - b. Out of the house strolled my mother's best friend.
- e. References to examples in the text should take the form "(1), (1a), (1a–d), (1)–(3)" with both number and letter in parentheses.
- f. Examples in languages other than English should include the following information:
 - i. Language name (if needed)
 - ii. Transcription (capitalize the first letter if it is a sentence and end it with a period)
 - iii. Gloss
 - iv. English translation
 - v. Source (if indicated)
- g. Linguistic examples with interlinear glossing should be presented according to the following rules (see the "Leipzig glossing rules"
 - $(\underline{https://www.eva.mpg.de/lingua/pdf/Glossing-Rules.pdf}\ for\ details).$
 - i. Word-by-word alignment → flush left
 - ii. Morpheme-by-morpheme correspondence → use of hyphen '-'
 - iii. One-to-many correspondences → use of dot '.'
 - iv. Grammatical markers in glosses should be presented in small capitals. Samples:
 - (4) *Dui, wo [shi [zuoye] ¬] xiewan-le. yes I EMP homework write-PERF 'I wrote the homework.'
 - I wrote the nomework.
 - (5) siastr-yn-y malunk-i sister-POSS-M.PL.NOM picture-M.PL.NOM 'the sister's pictures'
 - (6) Zhangsan geng guanxin ni. Zhangsan even.more care.about you 'Zhangsan cares more about you.'

7. Tables, figures, and illustrations

a. Tree structures should be regarded as examples and numbered accordingly. Sample:



- b. Titles are required for figures and tables. Capitalize the first letter of the first word.
- c. Numbering of figures and tables




Figure 1. Memory for spatial configuration (revised from Majid et al. 2004:110)

 - i. Tables and figures should be numbered consecutively throughout the text as Table 1, Table 2, Figure 1, Figure 2.... The title of a table should be above the table, while the title of a figure should be beneath the figure as shown below.

- ii. Tableaux of OT should be regarded as examples and presented in numerical order.
- d. Photographs and scanned images should be in high resolution, black and white or color. Please provide high-quality graphic files (jpg or similar) and original files (excel, ppt, etc.)

8. Citations

- a. Cited references should be placed in chronological order as shown below. (Ho 1977, Ferrell 1982, Chen 2006)
- b. Single work citation
 - i. One author: (Levinson 1996:375) or Levinson (1996:37)
 - ii. Two authors: (Wassmann & Dasen 1998:695) or Wassmann & Dasen (1998:695)
 - iii. Three authors: Wassmann, Dasen & Levinson (1998:695)
 - iv. Four or more authors: (Beck et al. 2004:325) or Beck et al. (2004:325)
- c. Multi work citation

(Schutze 1996, Myers 2009a)

Salvador (1957, 1964, 1977)

(Schuchardt 1885, Fidelholtz 1975, Hopper 1976, Bybee & Scheibman 1999, Bybee 2000b, 2001)

- d. Quotations within 40 words should be enclosed in double quotation marks in the text.
- e. Quotations with more than 40 words should appear as a block, separated from adjacent texts by one space line without quotation marks. For example,

As Langacker puts it:

Every use of a structure has a positive impact on its degree of entrenchment, whereas extended periods of disuse have a negative impact. With repeated use, a novel structure becomes progressively entrenched, to the point of becoming a unit; moreover, units are variably entrenched depending on the frequency of their occurrence . . . (Langacker 1987:59)

9. Appendices

- a. Appendices should be put right after the main text and before the references.
- b. Insert one space line between appendices and the main text.
- c. Add a title to each appendix as shown below:

d. Insert one space line between appendices.

10. References

- a. All and only the works cited in the running text should be listed in the reference section.
- b. Separate the reference section from the main text by two space lines. The section title "References" is required to be in bold.
- c. Format of references
 - i. Order of authors' names

One author: last name, first name.

Two authors: last name, first name, and first name last name.

Multiple authors: last name, first name, first name last name, and first name last name.

- ii. Whenever possible, please give the full names of authors and editors.
- iii. Italicize titles of books, journals, and proceedings.

- iv. Capitalize the first letter of each content word in titles of books, journals, proceedings, theses, and dissertations.
- v. Translate titles in languages other than English into English. The translation should be placed in square brackets immediately after the original title.

 Sample:
 - Huang, C.-T. James. 1988. Shuo 'shi' gen 'you' [On 'be' and 'have' in Chinese]. *The Bulletin of the Institute of History and Philosophy* 59:43–64. Taipei: Academia Sinica.
- vi. Whenever possible, please provide city names and abbreviations of states of publishers, e.g., Stanford, CA: CSLI Publications.
- vii. Indent 4 spaces for the second and subsequent lines of each reference.
- d. Sample reference entries
